# WOMEN IN GLOBAL HEALTH SECURITY

Achieving Gender-Responsive Global Health

SEPTEMBER 17TH 2020

We are writing to you on behalf of Women in Global Health, the Wagner Foundation and Foreign Policy, who are working in partnership to produce the Women in Global Health Security Summit which will be held during the United Nations General Assembly 2020 on a virtual platform on the 17th of September. As part of this summit we intend to start a conversation about gender-responsive leadership and global health security that will last beyond the current pandemic and build future resilience.

In light of COVID-19, we are collecting pledges that will reaffirm government's commitments towards the Sustainable Development Goals, Goal 5 - Achieve gender equality and empower all women and girls, and supported by the 73rd World Health Assembly COVID-19 Resolution. Gender equality has advanced in recent decades, but these gains are now under threat due to the current COVID-19 crisis. Gender equality remains a persistent challenge for countries worldwide and the lack of such equality is a major obstacle to sustainable development.

COVID-19 has caused widespread loss of life, suffering and disruption which is predicted to escalate as the virus spreads to vulnerable populations and communities without universal health coverage (UHC). Many lives will be lost because countries do not have resilient health systems based on UHC, and because fundamental gender inequities in the health workforce and wider society weaken our response to pandemic prevention and response.

# SDG GOAL 5: ACHIEVE GENDER EQUALITY AND EMPOWER ALL WOMEN AND GIRLS

To align with the Women in Global Health Security Summit objectives, we are asking governments to make values-based and approach-driven pledges and we are asking individuals and institutions to make measurable commitments towards gender-parity in global health security. We would be delighted if you would reaffirm the following points from Goal 5 within the context of global health security:

- 5.1: End all forms of discrimination against all women and girls everywhere by adopting a gender-sensitive approach to health security data collection/analysis and response management.
- 5.2: Eliminate all forms of violence against all women and girls in the public and private spheres, including trafficking and sexual and other types of exploitation - including providing health workers, most of whom are women, with safe and decent working conditions
- 5.4: Recognize and value unpaid care and domestic work through the provision of public services, infrastructure and social protection policies and the promotion of shared responsibility within the household and the family as nationally appropriate - including recognizing the value of women's unpaid care work by including it in the formal labor market
- 5.5: Ensure women's full and effective participation and equal opportunities for leadership at all levels of decision-making in political, economic and public life - including advocating for more women in global health security decision making structures and in public discourse.
- **5.6:** Ensure universal access to sexual and reproductive health and reproductive rights as agreed in accordance with the Programme of Action of the International Conference on Population and Development and the Beijing Platform for Action and the outcome documents of their review conferences.





We want to take this opportunity to ask you to continue to support Sustainable Development Goal 5 and to encourage others to support it during COVID-19 and the future by signing this pledge letter on behalf of your government.

Please join us as we confront the power and privilege that undermine global health by preventing women from contributing equally to the fight against challenges like this pandemic.

## **NEXT STEPS**

- 1. Review this document and decide if you could potentially make this pledge.
- 2. Arrange a call with our team, which includes Executive Director, Dr Roopa Dhatt and Deputy Director, Sarah Hillware, as well as the COVID 50/50 campaign team to discuss the various facets of your pledge and to answer any questions.
- 3. Finalize the pledge by 22nd of August 2020.
- 4. Receive the pledge confirmation letter.
- 5. Work with our team to promote the announcement, including but not limited to a feature on our website, social media and exploring your platforms.
